# Is now the time to adjust your 2022 tax strategy?

If you've just paid more in 2021 taxes than you'd like, is it time to re-think your approach for 2022? Here's how the <u>75% STO</u> <u>tax credit</u> could virtually eliminate your 2022 lowa income taxes. Find line 38 on your lowa income tax return. If your

income on line 38 is \$100,000, you'll owe \$6,517 in Iowa taxes. If you donate \$8,500 to the STO you will receive \$6,375 in tax credits. Here's the math: \$6,517 - \$6,375 = \$142 owed! If you've already paid Iowa taxes through your paycheck, you'll receive at least \$6,375 back! Below is a link to our 2022 Tax Scenario document with other examples.

#### Reserve tax credits with a 2022 Pledge

Almost 100 donors have already pledged their 2022 donations to reserve tax credits. Last year we ran out of credits in early December, so I'd encourage you to pledge now. If you're unsure of the exact size of your planned 2022 donation, make a conservative pledge guaranteeing the tax credits. You can always pledge or donate more if your tax situation warrants it.

#### Iowa Tax Reform law begins taking effect in 2023

The tax reform bill signed by Governor Reynolds will eventually create a flat income tax rate of 3.9% for all lowans and eliminate lowa income taxes on retirement income. While the retirement tax change will begin in 2023, the flat tax rate will start to inch lower beginning next year, but will not go into full effect until 2026. Please ask your financial advisor or CPA how this might impact your charitable giving and taxes for 2023.
